NOTICE No. 12 a / 2022

Pursuant to Art. 14 sec. 1, point 4 of the Act of 20 July 2017 – Water Law (Dz. U./Journal of Laws/ of 2017, item 1566) and Art. 43 sec. 6 of the Act of 21 December 2000 on Inland Navigation (Dz. U./Journal of Laws/ of 2001 No. 5, item 43), the Regional Water Management Board in Gdańsk informs that:

From 30 April 2022, the following waterways under the Regional Water Management Board in Gdańsk administration shall be opened to navigation:

- **Szarpawa River**, class II waterway (min. waterway depth in accordance with the regulation 1.8 m) current waterway depth 2.08 m with the water level of 499 cm at Tujsk water gauge
- **Wisła Królewiecka River**, class Ia waterway (min. waterway depth in accordance with the regulation 1.2 m) current waterway depth 2.08 m with the water level of 499 cm at Tujsk water gauge
- **Nogat River**, class II waterway (min. waterway depth in accordance with the regulation 1.8 m) the current water depth in some places does not meet the requirements (at km 0+600 of the waterway, i.e. below the Biała Góra lock towards the Vistula Lagoon, at the length of 30 m, there is a depth restriction of 176 cm with the water level of 186 cm at the water gauge located at the lower station of the Biała Góra lock. In the waterway km 24+500 and 30+800 i.e. below the Rakowiec lock towards the Vistula Lagoon, at the length of 30 m, there is a depth restriction of 174 cm with the water level of 196 cm at the water gauge located at the lower station of the Rakowiec lock. At the waterway km 39+000 i.e. below the Michałowo lock towards the Vistula Lagoon, at the length of 20 m, there is a depth restriction of 148 cm with the water level of 502 cm at the water gauge located at the lower station of the Michałowo lock 2.08 m with the water level of 502 cm at the water gauge located at the lower station of the Tujsk lock.
- **Jagiellonian Canal**, class II waterway (min. waterway depth in accordance with the regulation 2.2 m) the current waterway depth in some places does not meet the requirements (At km 3+300 at the length of 20 m there is a depth restriction of 190 cm with the water level of 502 cm at the water gauge located at the lower station of the Michałowo lock).
- **Tuga River** (Not in operation - waterway on the Tuga River will be opened after all the activities aimed to ensure safe and efficient navigation are completed. The opening of the waterway will be announced in a separate notice).
- **Elbląg Canal (km 46+300-52+00)** class Ia (min. water depth in accordance with the regulation 1.5 m), **Drużno Lake** class Ia (min. water depth in accordance with the regulation 1.2 m), **Elbląg River (0+000-3+900)** Ia (min. water depth in accordance with the regulation 1.2 m), Waterway marked with signs. At present, in some places it does not meet the requirements (at km 46+500 of the Elbląg Canal and at km 1+200 of Drużno Lake at lengths of 10 m and 30 m respectively, there is a depth restriction of 134 cm with the water level of 516 cm at the water gauge located at the lower station of the Całuny slipway).
- **Elbląg Canal (km 0+450+36+600)** class Ia (min. water depth in accordance with the regulation 1.5 m), **Pniewo lake**, **Sambród lake**, **Ruda Woda lake**, **Bartązek lake**, **Ilińsk**: class II (fairway depth in accordance with the regulation 1.8 m), **Bartnicki Canal (0+000-1+000)** class Ia (min. water depth in accordance with the regulation 1.5 m), The waterway is marked with signs. At present, in some places it does not meet the requirements. At km 21+200 and 32+100 of the waterway, i.e. below Ruda Woda lake, towards Buczyniec, at lengths of 10 m and 20 m respectively, there is a depth restriction of 140

cm with the water level of 885 cm at the water gauge located at the upper station of the Buczyniec slipway.

Caution - the a.n. current waterway depth restrictions refer to the water level today, i.e. 29 April 2022.

From 30 April 2022 the following slipways of the Elbląg Canal are in operation:

- **Buczyniec, Kąty:**
from Monday to Friday from 7:00 a.m to 8:00 p.m.
on Saturdays, Sundays and public holidays from 7:00 a.m to 8:00 p.m.
- **Oleśnica, Jelenie, Całuny:**
from Monday to Friday from 7:00 a.m to 7:00 p.m.
on Saturdays, Sundays and public holidays from 7:00 a.m to 7:00 p.m.

From 30 April 2002 the following locks are in operation:

- **Biała Góra, Szonowo, Rakowiec, Michałowo:**
from Monday to Friday from 7:00 a.m to 7:00 p.m.
on Saturdays, Sundays and public holidays from 7:00 a.m to 7:00 p.m.
(lockage of cargo vessels beyond the above-mentioned working hours is possible upon prior agreement with the facility manager at least 24 hours in advance).
